SCLMA President's Message Dr Roger Faint

Dr Dilip Dhupelia, President AMAQ, attended the SCLMA committee meeting and presented at our clinical meeting last Thursday 29th November.

What a meeting it was!

Also at the meeting presentations were updates on the new QLD Termination of Pregnancy Act 2018 (Dr Anders Faber-Swensson), new laws on prescribing Medicinal Marijuana (Dr Susan Ballantyne) and Dr Peter Georgius presenting on the latest Neuroscience of Chronic Regional Pain Syndrome. Dr Scott Masters has taken a new tone to the meetings, making them shorter and punchier. Well done.

Dr Dhupelia also answered questions from the floor and suggested that the AMAQ was very aware of recent SCLMA concerns regarding QLD public hospital access to private health insurance (PHI) and Medicare.

He also suggested that these issues were being experienced QLD wide and that the AMAQ was very supportive of our concerns.

He had already followed up the SCLMA concerns relating to PHI with emails to Dr John Wakefield (Deputy Director-General Clinical Excellence Division, QH) and Mr Scott Ponting (Acting Director, Revenue Strategy & Support Unit). The responses were disappointing as one might expect.

Ultimately, the SCLMA has been advised to obtain examples of inadequate patient consent or poorly informed patient choice relating to their PHI access and of 'double dipping'. These examples are then to be presented to the CEOs of the relevant health districts for appropriate action.

There was also a stark account by Dr Raewyn James regarding her mother being admitted to SCUH. She will follow her comments up with an email, however suffice to say her mother, she and her brother were approached multiple times in an attempt to access her PHI. Apparently the process of refusing PHI access was very uncomfortable. I urge any member who has had similar personal experiences to please contact the SCLMA in writing.

Dr Dhupelia also updated our meeting with current topical QLD issues including the Termination

of Pregnancy Act 2018, pharmacists having greater 'medical responsibility' through the establishment of a QLD pharmacy council, the disappointing mandatory reporting result and the recent announced enquiry into voluntary assisted dying laws.

November. As some of you may know, Dr Phoebe is
the director of Medscribe, a medical scribe staffing

AMA Queensland to fight against Pharmacy Inquiry recommendations

AMA Queensland has formed a working group, which will devise a strategy to push back against the Queensland Parliament's Health Committee reports' recommendations.

AMA Queensland is deeply concerned with the recommendations, which include allowing pharmacists who give out low-emergency and repeat prescriptions, and setting up a Queensland Pharmacy Advisory Council without the involvement of medical professionals.

The AMA Queensland working group will work closely with both the Federal AMA and the medical colleges with the ultimate aim of ensuring that patient safety is protected and that decision makers understand the dangers an expanded scope of practice for pharmacists could mean for the Queensland health system.

We will keep members abreast of any updates on this issue.

AMA Queensland meets with the Colleges

In our ongoing efforts to support, promote and advocate for the medical profession in Queensland, AMA Queensland recently convened a roundtable of the combined Colleges, including the Royal Colleges of General Practitioners, Physicians, Surgeons, Ophthalmologists, Psychiatrists, the College of Emergency Medicine and the College of Rural and Remote Medicine.

It was very positive and productive roundtable. The group discussed a number of issues, including Queensland Health's continuing efforts to expand scope of practice for non-medical health professionals and the proposed pharmacy council.

We also discussed the new laws surrounding mandatory reporting and all agreed that

- · The wording of the bill was ambiguous and as a result doctors would avoid seeking treatment;
- Doctors deserved the same level of access to care for their own health as they provide for their patients;
- Practitioners were also patients and should have equal right to access confidential high quality medical treatment as their own patients and all other Australians; and
- Improved practitioner health led to improved patient protection.

AMA Queensland and the Colleges agreed to progress a joint statement on the new mandatory reporting legislation, expressing disappointment at the lack of genuine, positive reform these laws represent and urging the State Government to make improvements to the Bill.

Eradicating Hepatitis C

The dream of eradicating Hepatitis C from Australia is almost a reality thanks to two of our GP members. Dr Matt Young and Dr Joss O'Loan volunteer their time and resources to take hepatitis C treatment directly to disenfranchised and chronically marginalised people.

In October, the AMAQ Foundation raised \$7,000 at the Dinner for the Profession for their Hep C Kombi Clinic project, enabling treatment for 100 new hepatitis C patients.

More services for our community

I am pleased to confirm our Plastic and Reconstructive Surgery Unit at SCUH is now open to external referrals from GPs.

So far, the service has treated more than 100 patients for more than 200 skin cancers. We are excited that our range of services has now expanded as we build capability in our tertiary facility.

Our New Plastics and Reconstructive Service

For skin cancer patients, the attachment of a clinical photograph is essential to assess suitability for Rapid Access Plastic Interventional Day Clinic (R.A.P.I.D. clinic) which is same day surgery for patients with single facial lesions under local anaesthetic only.

As the service is continuing to grow in a safe and sustainable manner, there will be patients whose care is beyond the current scope of practice, that may require treatment at Royal Brisbane and Women's Hospital or Queensland Children's Hospital including major burns, facial trauma, complex reconstruction and paediatric surgery.

Planned growth throughout 2019 and beyond will see increasing case complexity at SCUH building toward an acute on call service.

Our Commitment to Improving Access to Ophthalmology Services

Our health service has amongst the highest percentage of their population over 65 years of age compared to Queensland and this percentage is projected to significantly increase.

By 2021, the 65+ age group will account for 22 percent of the Sunshine Coast population.

We know that vision loss trebles for every decade of life after 40 years of age, and further impacting the demand is the increasing rate of chronic disease, in particular, diabetes.

Visual impairment can affect mobility; it may also affect the risk of falls and injury including hip fractures. Our ophthalmology services are therefore vital to our local community as part of quality of life and integrated care planning with our community partners, and we are committed to providing timely access. By way of example, we had 3500 patients (1700 long wait patients) on the wait list at 4 to 5 year wait times just 11 months ago. We now have 674 patients waiting, of whom 24 are long wait patients. Whilst this reduction is one of the most significant service access improvements across Queensland, we strive to ensure we don't have patients waiting longer than clinically recommended.

We have been challenged in successfully recruiting Ophthalmologists to the public system, which is not unique to Sunshine Coast. We are excited that we have been able to recruit 2 locums recently, who will start soon, whilst we continue our efforts to recruit permanently. We have implemented clinical prioritisation criteria, which also includes an Optometrist Report to accompany a GP referral, increased our outpatient clinics, are recruiting an additional Orthoptist with increased scope to include identifying eye diseases and neuro-ophthalmic disorders, provide low vision assessments, rehabilitation and to assist with ocular motility disorders and paediatrics conditions.

With approximately one third of all new referrals requiring ongoing medical treatment, the initiation of new treatment pathways, with appropriately skilled members of the multidisciplinary team, will increase the number of new clinic appointments for our medical specialists.

Next Milestone for the redevelopment of Nambour General Hospital

I'm pleased to advise that Lendlease Building Pty Ltd has been announced as the successful managing contractor for the \$86.239 million Nambour General Hospital redevelopment. This is an exciting milestone for our community and we look forward to involving our consumers in the detailed design process which will begin soon. The redevelopment of NGH will be completed in multiple stages ensuring minimal disruption to the delivery of health care services. Construction will commence in 2019 and is expected to be completed by end 2022.

New Termination of Pregnancy Law

As of 3 December 2018, the Termination of Pregnancy Act 2018 (the Act) applies to termination of Pregnancy in Queensland. Termination performed by a registered medical practitioner, is no longer a criminal offence under the Criminal Code; nor is it a criminal offence for a woman to consent to, assist in or perform a termination on herself; nor is it a criminal offence to assist a woman to obtain a termination or supply her with the means to do so. SCHHS is partnering with the PHN to provide education and information to GPs, as well as the wider community. Referral guidelines and decision support tools also available on Health Pathways.

Looking after the Carers

Looking after our team at Sunshine Coast HHS is very important to us. So, we were very proud of Doctors Bethany Boulton and Ashwini Amaratunga who were recently recognised for their amazing leadership and commitment to Physician wellbeing, through their nomination

for the Australasian College of Emergency Medicine (ACEM) Wellbeing Award.



GAMBLING ADDICTION.

One of the more disturbing phenomena that we observe today is the meteoric rise advertising media gambling. bookmakers and Some offer incentives that sound too good to be true, which usually means that they

Everybody knows that providers of gambling services, whether bookmakers or poker machines or Lotto, have a clear business model. A percentage of the income is returned to the punter and the rest is administrative costs and profit. Pokies can be programmed to return predetermined percentages. Lotto has an approved percentage. The figures are typically around 50% of the gross take being returned to the investor. Bookmakers' profit margins have historically been less than that, so it is curious that the larger players can now offer incentives and still count on a profit. A bookie's profit margin is precalculated, because the odds are offered to produce a known return. For the modern bookmaker, as for the time-honoured totaliser, the profit margin is no gamble.

Addictions take all shapes and sizes. addiction is a silent epidemic. It is often difficult to identify because it is seen as a game and as central to the funding of some sports. Not-for-profit organizations rely on raffles as a mainstay of fundraising [how many citizens disapprove strongly of the Mater or Endeavour prize homes?] Gambling is seen as harmless fun. It is not harmless. Gambling addicts have been well known to lose far more than they can afford. Hence the signs in the toilets in casinos, and the little rider at the end of the TV ads: "Remember, gamble responsibly". How do you conduct an irresponsible activity responsibly? "Responsible gambling" for some people is like riskfree mountain-climbing. Even harmless fun can be damaging. I had a patient, a little old lady, whose losses at bingo were so great that she could not pay her rent or buy groceries - she was placed under financial administration so her rent and grocery bills were quarantined. Bingo!

The AMA lobbied to have tobacco advertising progressively removed from public media, starting with prime time TV when children were viewing. There are limitations on alcohol advertising – we do not see alcohol advertising closely associated with motor sports. These examples should be taken as a model of the medical profession's approach to gambling advertising. If it causes physical or psychological or social harm, doctors have a role in minimizing the harm.

Footnote: can we ever apply this same logic to advertising that feeds shopping addiction??

STAGED DOSING.

Some patients cannot be trusted to manage their own medications, especially substances of abuse such as opiates and benzodiazepines. Addiction specialists are almost as concerned about Seroquel and Lyrica, two commonly-prescribed and supposedly nonaddictive drugs which are known by the drug-using subculture to have mind-changing effects which give them a street value.

When we recognize that a patient is misusing or overusing prescribed substances of concern to us, one of the strategies open to us is staged dosing. We can endorse the prescription to require the pharmacist to dispense the medicine weekly, twice-weekly, or even daily, and in the most troubling cases can endorse the prescription for the pharmacist to observe the dosing.

Pharmacists are interested in medication safety and are generally prepared to do this. But at a cost – to the patient. Typical costs are \$5-\$15 per week, or sometimes \$5 per dose in the case of daily dosing. This is actually a very moderate charge, considering the time taken for a health professional to perform the task and keep it accurately documented. Patients hate it, more because of the cost than because of the inconvenience and slur on their reputation. Patients put on staged dosing know that they have done wrong and are mostly prepared to wear it in order to maintain their supply of their chosen medication.

There is a partial solution available to some patients. The federal government has made available a special payment to pharmacists to cover the additional charge for staged dosing. But only to a maximum of 15 patients (per pharmacist or per pharmacy? Sorry, I am not sure). So if you want to impose staged dosing on a miscreant patient, one of the obstacles to medication safety has been partly eliminated.



5 Estate Planning tactics to preserve Family Wealth



Over the years we have witnessed first-hand what can happen when a client's Estate Plan hasn't been structured correctly.

We think it's important to preserve the Family Wealth and pass assets onto future generations, below are 5 key points to think about and act on.

1. Start with a Structure review

Assets can be held in different names/entities based on your past purchases, inheritances or marital splits. A review of what legal entity is the owner of assets should be undertaken as there are ways to "structure" the ownership of assets to assist and minimise the passing of family assets to the next generation. Effective structuring can save on financial or taxation consequences.

2. Super is not part of your Estate

Why does super need to be reviewed? Super does not automatically form part of a person's estate. Whilst we see most clients do have a Will in place, often their superannuation has not been considered.

TIP: A member can elect to include their death benefit in their estate by completing a binding or non-lapsing death nomination in favour of either their financial dependants or their legal personal representative. This is a very important election as a correct election can save tax where a financial dependant exists.

3. Plan your Business Exit

If you run and own your own business, you'll need to think how someday you will exit that business. The processes you put in place surrounding your exit can have a huge impact on your retirement plans both in time and money.

TIP: Business owners need to prepare a plan for their exit, their successors, how the successors will fund future ownership and how you address legal & tax issues. This should ensure your assets are protected and you are compensated for all of your hard work in retirement.

4. Consider Aged Care fees

Be aware of Aged Care fees and possibly create a strategy to fund future care to ensure family assets are structured to pay for your own Aged Care costs. Potential Centrelink issues should also be considered when creating this strategy.

TIP: Ensure a percentage of investments have the liquidity to be readily available to fund accommodation payments, basic daily care fees and other fees for additional services.

5. Seek ongoing support

We often come across clients who created an Estate Plan and then have never updated or sought advice as their circumstances change. Not only do family assets change but so do family members via marriage, divorce, births & deaths etc.

TIP: Regularly update your Accountant and Investment advisor with family updates regardless of how big or small to help protect your family assets and to have peace of mind.

The Acute Knee Clinic

The first few days can make all the difference in recovery from a sporting injury.

Dr Steve Lawrie at the Sunshine Coast Orthopaedic Clinic provides an Acute Knee Clinic each Monday and Tuesday which is specifically designed for, but not limited to, sports injuries of the knee with a view to rapid assessment, investigation and adoption of a management plan within the first few days of the initial injury.

The Acute Knee Clinic has now been running for twelve years. We have treated many professional and semi-professional athletes as well as the "weekend warriors", including a special interest in paediatric sporting injuries. Dr Lawrie has a close association with many sporting teams on the Sunshine Coast, including the Sunshine Coast Falcons, Melbourne Storm and many other local clubs.

Specific conditions that can benefit from emergent assessment include suspected ligamentous injuries, including cruciate ligaments, medial ligaments, multiple ligament injuries, acute patellar dislocation, locked knees and especially paediatric cruciate and meniscal injuries whether that be by implementing early surgical techniques

or an appropriate non-operative treatment programme.

To access the Acute Knee Clinic, a patient needs to have a current referral to Dr Steven Lawrie and plain x-rays of the knee should also be arranged before the initial consultation.

A plain x-ray is very important in the initial assessment to exclude fractures, loose bodies, and to show the alignment of the knee joint and the patellofemoral joint, which cannot be seen on other investigations, such as an MRI scan.

Splints and orthotics can be organized directly with Leonie Walton on 5473 5858. Leonie attends our clinic on a Thursday afternoon, but she is available throughout the week as needed.

The Acute Knee Clinic is intended to complement Dr Lawrie's other interests, including hip and knee replacement, revision arthroplasty, computer assisted joint replacement, cartilage surgery, as well as hip, knee and ankle arthroscopy.

Dr Lawrie is happy to take phone calls for advice, queries etc as this often helps the referral process.


A medial ligament injury is usually easily treated in a range of motion brace, using an MCL protocol if applied with the 1st week or so. But it can be extremely difficult to correct if there is a delay of a number of weeks.

Paediatric meniscal tears may be repairable early after an injury, but a delay typically means meniscal resection becomes necessary.

Acute patellar dislocation may respond to surgical repair if surgery is offered in the first 2 weeks after the injury.

Traumatic meniscal tears where early repair rather than delayed resection can make a dramatic difference in outcomes

MANAGING PATIENTS WITH AF WHO ARE AT HIGH RISK OF STROKE AND BLEEDING: **LEFT ATRIAL APPENDAGE CLOSURE**

Managing high risk patients with non-valvular atrial fibrillation can be challenging. All patients need to consider the risks and benefits of oral anticoagulation to minimise stroke. However, some patients have significant comorbidities and/or a history of bleeding that precludes anticoagulation.

An option for these patients is Left Atrial Appendage Closure (LAAC). Two devices are currently available: the Watchman (BSCi) and Amulet (Abbott) Devices. These devices are intended to prevent thrombus embolization from the left atrial appendage and reduce the risk of life-threatening bleeding events in patients with non-valvular atrial fibrillation who have a contraindication to anticoagulation therapy.

President's Report: Dr Roger Faint

Main points from AGM address:

- Our website is improving and communication is improving through our Facebook page which now has over 180 followers.
- What local issues has the SCLMA achieved and contributed to with this year? Issues have included Orthopaedic registrar training concerns, the necessary withdrawal of surgical outsourcing to SCUPH, Medicare funding for specialist services and of course public hospitals accessing private health funding.
- There are also internal operative issues of course which we are improving month by month. For example, we will have a membership survey soon to ensure we are representing our members' interests in the future.
- The Sunshine Coast is growing in population, as is our state population and with this growth is the need for health services. Of course this increase in population has created imaginative ways to improve funding, provide medical services and communicate within and outside of the public and private health systems.
- There are good things happening such as the improved variety specialist services, both public and private, the ongoing excellent work by our GP liaison officers and the work of community services such as our local PHN.
- However there is frustration and concern about how funds are raised through Medicare and private health funds to support the local hospital and state health system.
- Through the SCLMA lobbying, Dr Dilip Dhuphelia (AMAQ President) and Dr John Wakefield (Qld Health Deputy-Director General, Clinical Excellence Division, will be visiting our clinical meeting in November this year. Points to be discussed will include: Issues and concerns around private practice and public health care and funding; Named referral changes (named doctor to see patient) and Commonwealth / Medicare billing. This is the SCLMA members' opportunity to show support and

- ask the hard questions regarding the funding of QH public hospitals through Medicare and private health funds. I encourage all to attend.
- Buderim Private Hospital Emergency Department: Feedback that it is going well and in demand
- Positive correspondence from Adj. Prof Naomi Dwyer, CR, SCHHS re co-operation regarding future health career education.

Vice President's Report : Dr Wayne Herdy (and AMAQ Councillor's Report)

Residential Care:

- 16% GPs attend nursing homes only 6% regularly. Most women doctors don't stay very long. Carers, nurses, quality of nursing, abuse will be subject of investigation.

"I may look like just an ordinary guy," he said to her, "But in just a few years my father will die and I will inherit \$200 million".




